Boldt is using campaign signs that infer he has been endorsed by the County Republican Party. He is running as non-partisan, although he's filed his PDC's as a Republican, and the local Republican Party expelled Boldt in 2011. In this election they are endorsing a Republican write in candidate.

Boldt's campaign signs indicate Republican endorsement, a deliberate attempt to misinform voters as to Republican Party Support.

The group name is "Republicans of Clark County," yet they are a rump group with no standing or recognition from the State or Local GOP, and this is being done deliberately in an effort to confuse the voters.

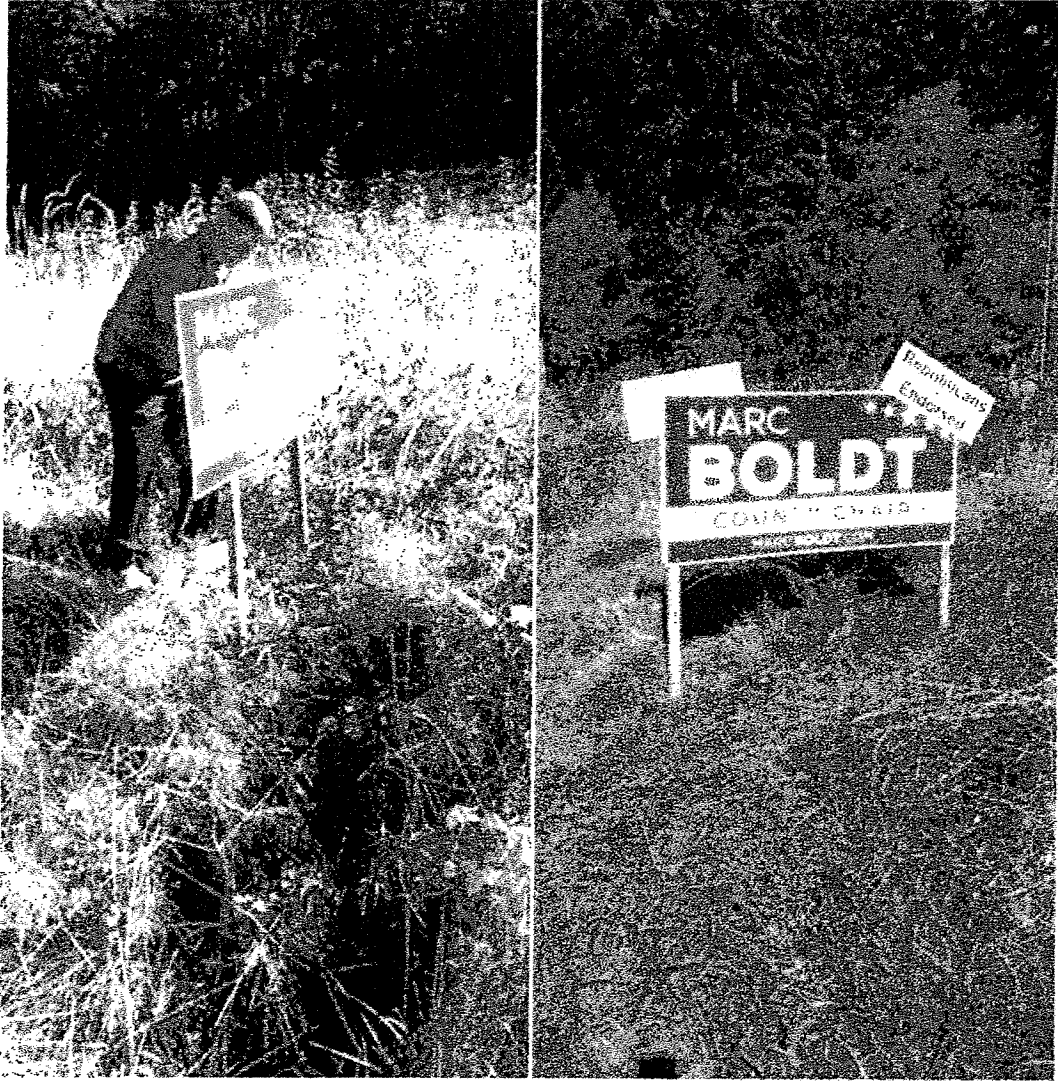
